The Clarendon Hills Park District requires a 1:8 Supervisor to Camper ratio must be maintained at all times. A Supervisor is defined as 18 years or older. If the Supervisor to Camper ratio is not upheld at the date/time of the rental, the camp will not be allowed in the facility.

Terms and Conditions of Rental Agreement

Renter understands and agrees that it is the Renter's sole responsibility to provide supervision for any and all activities contemplated by this agreement. Renter further understands and acknowledges that lifeguards are not responsible for providing supervision; rather lifeguards are responsible for enforcing safety rules and responding to emergencies. Clarendon Hills Park District shall provide a swim test for all groups entering the swimming facility however, the Renter and Renter's guests are ultimately responsible for determining whether members of their group have appropriate swimming skills for any aquatic activity contemplated by this agreement and that the Clarendon Hills Park District is not responsible for assessing the skills of any patron.

Additionally, Renter understands and agrees that children **12 years of age and younger** must be supervised at all times by a responsible person, 18 years of age or older and it is Renter's responsibility to enforce this requirement. Accordingly, Renter agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this event.

Renter agrees to protect, indemnify, save, defend and hold harmless the Clarendon Hills Park District including its officers, officials, employees, agents, and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and

expenses, (including reasonable attorney fees) which the District may become obligated by reason of any accident, injury, or drowning of any member of Renter's group (or caused by a member of the renters group) arising indirectly or directly in connection with or under this agreement.

Renter shall maintain general liability insurance for bodily injury, personal injury and property damage during the term of this agreement, specifically including contractual liability coverage. The insurance shall name the Clarendon Hills Park District as **additional insured** and shall contain no special limitation on the scope of protection afforded the District. The insurance shall have limits of not less than \$1,000,000 per occurrence for injury or death. Renter's insurance shall be primary insurance as respects the Clarendon Hills Park District. Any insurance maintained by the Clarendon Hills Park District shall be in excess of the Renter's insurance and shall not contribute with it. Renter's insurer shall agree to waive all rights of subrogation against the District. Renter shall provide certificate of insurance no later than five days prior to the rental date.

Renter shall have use of the facility for the date and time stated above and shall fully comply with all Lions Park Pool rules as posted in connection with use of the facility. The Clarendon Hills Park District reserves the right to cancel or revoke this agreement at any time for any reason, including, but not limited to inclement weather, Renter misconduct, or because the Renter has breached any of its obligations under this agreement.
