The Clarendon Hills Park District requires a 1:10 Supervisor to child ratio must be maintained at all times. A Supervisor is defined as 18 years or older. If the Supervisor to child ratio is not upheld at the date/time of the rental, the camp will not be allowed in the facility. A higher ratio of Supervisor to child, example: 1:8 is STRONGLY recommended.

Terms and Conditions of Rental Agreement

Renter understands and agrees that it is the Renter's sole responsibility to provide supervision for any and all activities contemplated by this agreement. Renter further understands and acknowledges that lifeguards are not responsible for providing supervision; rather lifeguards are responsible for enforcing safety rules and responding to emergencies. The Renter and Renter's guests are ultimately responsible for determining whether members of their group have appropriate swimming skills for any aquatic activity contemplated by this agreement and that the Clarendon Hills Park District is not responsible for assessing the skills of any patron.

Additionally, Renter understands and agrees that children **12 years of age and younger** must be supervised at all times by a responsible person, 18 years of age or older and it is Renter's responsibility to enforce this requirement. Accordingly, Renter agrees that he/she shall communicate this requirement to all guests/patrons associated with and attending this event.

Renter agrees to protect, indemnify, save, defend and hold harmless the Clarendon Hills Park District including its officers, officials, employees, agents, and volunteers (collectively "District") from and against any and all liabilities, obligations, claims, damages, causes of action, costs and expenses, (*including reasonable attorney fees*) which the District may become obligated by reason of any accident, injury, or drowning of any member of Renter's group (*or caused by a member of the renters group*) arising indirectly or directly in connection with or under this agreement.

Renter shall have use of the facility for the date and time stated above and shall fully comply with all Lions Park Pool rules as posted in connection with use of the facility. The Clarendon Hills Park District reserves the right to cancel or revoke this agreement at any time for any reason, including, but not limited to inclement weather, Renter misconduct, or because the Renter has breached any of its obligations under this agreement.
