Committee Reports

Finance/Personnel Committee

Treasurer Lee Howard presented the Combined Budget/Appropriation Ordinance for the fiscal year ending April 30, 2023. He explained that this was a balanced budget. Surplus from the General and Recreation Funds would be transferred to the Capital Projects Fund for additional Capital Improvements. Aquatics Committee
